Diisobutyl phthalate (DIBP) and Aluminium are minor components in the catalytic system used to produce Capilene® base resin. They are NOT used as additives, but rather as "aids to polymerization", as defined by EU regulation No. 10/2011. Analytical testing of Aluminium and DIBP in several Capilene® resins resulted in undetectable content (<0.1 ppm).

Please note that the users must verify that the finished articles are in compliance with the defined SML.

- E 470a: Calcium salts of fatty acids
- E 471: Mono- and diglycerides of fatty acids
