

# Capilene<sup>®</sup> Polypropylene Ipethene<sup>®</sup> Low Density Polyethylene

## Compliance with REACH Regulation (EC) No 1907/2006

Carmel Olefins Ltd. has successfully registered the monomers related to its polypropylene resins commercialized under the name **Capilene<sup>®</sup>**, and to its polyethylene resins commercialized under the name **Ipethene<sup>®</sup>** in volumes > 1000 tons/year.

This was done by Carmel Olefins' Only-Representative (OR) Ducor Petrochemicals, with compliance with Regulation (EC) No. 1907/2006 concerning the **Registration, Evaluation, Authorization and the Restriction of Chemicals (REACH)** and subsequent amendments.

**Capilene<sup>®</sup> & Ipethene<sup>®</sup>** grades comply with relevant requirements and restrictions of Annex XVII to (EC) regulation No 1907/2006 (REACH) and subsequent amendments up to and including Commission Regulation (EU) 2025/660.

**Capilene<sup>®</sup> & Ipethene<sup>®</sup>** grades do not contain any ingredients above the 0.1% (w/w) threshold as stated in Article 57 to REACH regulation (No. 1907/2006) that are listed in:

- Annex XIV (Authorization List) published in accordance with Article 57 (a-f) to the REACH regulation No 1907/2006 and subsequent amendments up to Commission Regulation (EU) 2022/586.
- The annex XIV candidate list of Substances of Very High Concern (SVHC) published in accordance with Article 59 of the REACH Regulation. Last updated on June 25<sup>th</sup>, 2025.

Substances included in the candidate list for eventual inclusion in Annex XIV are those that meet criteria for classification set in Article 57:

- (a) carcinogenicity category 1A or 1B (CMR);
- (b) germ cell mutagenicity category 1A or 1B (CMR);
- (c) reproductive toxicity category 1A or 1B (CMR);
- (d) persistent, bioaccumulative and toxic;
- (e) very persistent and very bioaccumulative;
- (f) having endocrine disrupting properties
