## REACH Registration / REACH Annex XIV and XVII / SVHC

### REACH Registration

REACH stands for the Registration, Evaluation and Authorisation of Chemicals. This EU Regulation 1907/2006 centralizes and simplifies chemicals legislation throughout Europe and entered into force on 1. June 2007.

In principle, all substances as such or in preparations under REACH which are produced or imported in quantities of 1 ton or more per year per company have to be registered by the respective companies in the Chemicals Agency in Helsinki. Depending on the quantity and hazard of a substance, different deadlines apply for registration. All substances > 1 ton have to be registered on the EU market on 1 June 2018. If a substance > 1 ton is not registered by the manufacturer or importer, it is not allowed to be used or marketed.

Masterbatches, as produced by KAFRIT Industries (1993) Ltd., are preparations according to REACH and exempted from registration. We herewith confirm that all substances used in the formulation of the above mentioned product is either

- registered (according to their relevant registration deadline ) or
- exempted from registration.

## SVHC (Substances of Very High Concern)

A substance of very high concern (SVHC) is a chemical substance (or part of a group of chemical substances) for which it has been proposed that the use within the European Union be subject to authorization under the REACH Regulation (Annex XIV).

Indeed, listing of a substance as an SVHC (candidate list) by the European Chemicals Agency (ECHA) is the first step in the procedure for restriction of use of a chemical.

REACH requires companies to inform their commercial customers, if a chemical is identified in the list and if more than 0.1 percent is contained in their products.

According to the information provided by our suppliers we herewith confirm that the substances below are not intentionally used or added(\*) during manufacturing of the above mentioned product.

Intentionally used or added means to achieve a physical or chemical effect during processing of the plastic or in the final material or article; it is intended to be present in the final material or article.
