

REACH/SVHC/RoHS Declaration

Products **PLUSTEK PB142NT-UK**

Polyram UK Ltd affirms compliance of the above listed product(s) with:

REACH – The Registration, Evaluation, Authorisation and Restriction of Chemicals Regulation (EC) 1907/2006.

The above listed products manufactured and placed on the market by Polyram UK Ltd are polymer compounds that are defined as mixtures under the EU REACH Regulation.

Whilst polymers are exempted as such from REACH registration, Polyram UK Ltd confirms that relevant starting monomers, mixture components and substances used in these products are registered as necessary, in accordance with REACH requirements, by us or upstream actors in the supply chain.

Registration numbers of specific component substances classified as hazardous according to REACH Article 31(9) and legally required to be communicated are listed on the SDS for the relevant product, as appropriate.

SVHC – The Candidate List of substances of very high concern for Authorisation, consisting of 235 items as most recently updated by ECHA on 14th June 2023 (see appended links).

Polyram UK Ltd confirms that SVHC as referenced above are not intentionally present in the raw materials used as formulation ingredients in the above listed grades, nor are they otherwise introduced intentionally during their manufacture.

The possibility of trace levels of some listed substances being present as impurities in component raw materials supplied to us by third parties cannot be excluded, but following our technical evaluation of the raw materials used in these compounds, they are not expected to be present above the threshold limit of 0.1% (w/w). Please note however that Polyram UK Ltd does not analyse its incoming raw materials or finished products for the chemicals and substances detailed in this document.

‘RoHS 3’ – Directive (EU) 2015/863 amending Annex II of the ‘Restriction of Hazardous Substances in Electrical and Electronic Equipment’ (RoHS 3) Directive 2011/65/EU and the applicable threshold levels of substances as amended to date (Lead, Chrome VI, Mercury, BBP, DBP, DEHP, DIBP, PBB, and PBDE materials restricted to 0.1% maximum, Cadmium to 0.01%).
